### Get on I-30 E from Cadiz St and South St. Paul Street

- 4 min (0.8 mi)
- 1. Head east toward Browder St  
299 ft
- 2. Turn right onto Browder St  
233 ft
- 3. Turn right onto Canton St  
194 ft
- 4. Turn left onto Browder St  
335 ft
- 5. Turn left onto Cadiz St  
0.2 mi
- 6. Turn right onto South St. Paul Street  
0.2 mi
- 7. Use the left lane to turn left onto the Interstate 30 E ramp  
105 ft
- 8. Keep left at the fork, follow signs for I-30 E and merge onto I-30 E

**Take US-80 E and I-20 E to FM 17 in Van Zandt County. Take exit 528 from I-20 E**

- 9. Merge onto I-30 E

- 10. Use the 2nd from the right lane to keep right at the fork, continue on US-80 E and follow signs for Terrell/Big Town Blvd

- 11. Keep left to stay on US-80 E, follow signs for Terrell

- 12. Continue onto TX-557 Spur E

- 13. Merge onto I-20 E

- 14. Take exit 528 toward Grand Saline
